**ORDER:**

**3.** The administrative department and the Head of Department concerned shall furnish details of all vacant posts authorized in this order, including the local cadre wise/roster points and qualifications, etc., to the recruiting agency immediately under intimation to Finance Department. The Department shall issue necessary amendments to their service rules/Bye-laws/Government Orders changing the existing recruitment procedure/recruiting agency wherever necessary.
